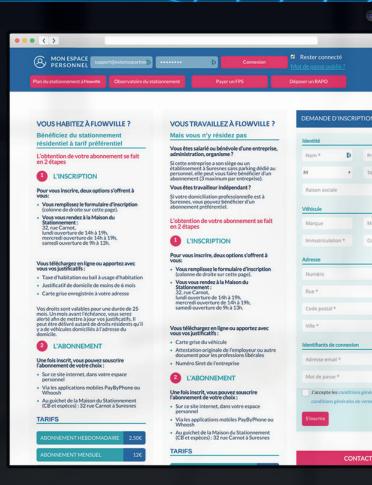

#### **EXTENSO** RIGHTS MANAGEMENT MODULE

The Extenso rights and subscription management solution is a simple and user-friendly tool that covers the needs of all the different parties involved: users, employees who process rights applications, managers, treasurers, operators, etc. Extenso offers everyone a reliable and secure solution that is interoperable with most solutions in the market.

#### An open solution that is ready for use

Extenso adapts to the specific needs of each city relating to the **creation** and management of user categories (or "profiles") with no limit on the number of different profiles, their **rights**, and corresponding subscriptions. Rights and **subscriptions** may be defined on the basis of a number of criteria: duration, validity zones, type of vehicle, type of energy or fuel powering the vehicle, quotas defined by household, by zones, etc.

The Extenso solution is connected to the Flowbird ticket server and can generate subscriptions that may be discontinuous in time (e.g. parking rights on Tuesdays and Thursdays), or may apply to several zones. It delivers paperless documents, which may also be issued in physical form, to users in accordance with their rights.

## For users, a simple internet portal that is available around the clock

Users can access a dedicated internet platform for filing their rights applications and supporting documents online. After their rights have been issued by the city, they can purchase their subscription by paying for it online using a wide range of payment methods. From their personalised area, a history of their subscriptions also allows them to access and download their invoices. Similarly, they can also modify their vehicles, thus considerably saving time and gaining flexibility.



### An efficient and adaptable solution for city authorities

The internet portal designed for users can be integrated into the city's website. This highly appreciated service makes subscriber management entirely paperless, thus limiting fraud and reducing the workload of city employees, as users digitise their supporting documents themselves. Besides, the solution is reliable and secure, with a document archival system that complies with the General Data Protection Regulation (GDPR).

## Optimised rights management tools for employees and operators

The Extenso solution offers simple tools for managing validation rules, an integrated workflow for validating the granting of rights and for managing allocation quotas by zone or by household. The solution can take account of the types of vehicles and fuel in order to enable the city to implement a responsible policy in the event of pollution peaks. These features are supplemented by financial reporting that is comprehensive and accurate, since the solution can be connected to the vast majority of sales channels:

- Flowbird, Cale or IEM Pay & Display machines,
- EasyPark, OPnGO, ParkNow, Paybyphone smartphone payment applications from Flowbird,
- off-street parking management solution: Minipark from Flowbird, Thales, Axiom.

Because of its interoperability with other suppliers, the Extenso solution can be rolled out by a city in no time. Revenue from the different sales channels becomes easier to trace, allowing for full transparency towards the public treasury.
